LEVEL 2 INSTRUCTOR CERTIFICATION TERMS, LIABILITY WAIVER & PARTICIPATION AGREEMENT

By registering for the IKO Level 2 Certification Course, Participant agrees to the following:

1. ELIGIBILITY & EXPERIENCE REQUIREMENTS

Prior kettlebell sport experience is recommended.

Level 2 is designed for Level 1 instructors, fitness enthusiasts, personal trainers, coaches, and athletes seeking to deepen their understanding of kettlebell sport and develop professional coaching skills.

Participant should possess practical experience with:

- Double Kettlebell Clean
- Double Kettlebell Jerk
- One-Hand Switch Snatch

No competition experience is required.

Previous completion of Level 1 Certification or equivalent experience is strongly recommended.

Participant represents that they:

- Are in general good health
- Are free from acute illness or active injury that would prevent safe participation
- Are able to perform basic physical activity without significant pain or discomfort
- Understand that all practical exercises should be performed according to individual abilities and limitations

IKO reserves the right to withhold certification if course requirements are not met.

2. ATTENDANCE REQUIREMENTS

Live attendance is encouraged, but not mandatory.

Participants are free to join and leave the live online sessions according to their schedule and individual needs.

Course recordings will be available to all participants for three (3) months following the event.

Certification requirements are as follows:

- Participants attending the live event must submit the Knowledge Test within seven (7) days following the completion of the live event.
 - Participants who do not attend the live event must watch the recording within ten (10) days following the live event and submit the Knowledge Test within seventeen (17) days following the live event.
 - Successful completion of both the Knowledge and Practical Tests is required for certification.

All participation fees are strictly non-refundable.

By registering, Participant acknowledges that:

- No monetary refunds will be issued for any reason, including illness, scheduling conflicts, travel issues, or technical difficulties.

To the fullest extent permitted by law, Participant releases and holds harmless:

International Kettlebell Organization (IKO), Denis Vasilev, instructors, agents, and affiliates, from any and all claims, liabilities, damages, or causes of action arising from participation in the Level 1 Certification, including claims based on ordinary negligence.

This release does not apply to gross negligence or willful misconduct.
